Dear Prime Minister,

On behalf of the Polish, Czech and Hungarian civil society we appeal to you to support the decision to adopt the European Union goal to become climate neutral by 2050 at the latest. This decision has to be taken on 12-13 December 2019, during the next meeting of the European Council. We realise that reaching for climate neutrality is a challenge, nonetheless it is possible and necessary.

Countries of our region have already chosen the road of transformation once and we have learned a lot on the way. It has not been an easy road, but it brought us freedom and the effects are beneficial to our societies. We can be proud of our achievements. Therefore we should also look forward to meeting these new challenges with courage.

Politics is about difficult choices and taking responsibility for the current time, but also for future generations. Making hard, long-term decisions is what defines great politicians. Now it is the time to make such a decision.

By making such visionary choices, we will gain greater long-term prosperity and safety in our societies. A transition towards a climate neutral economy will be socially and economically beneficial. Extensive funds are available for "socially just" transitions which do not leave communities behind and can support the most vulnerable.

We also experience water scarcity across Europe, droughts, rising food prices and threats to our safety that originate from extreme weather events.

Poland, Czechia and Hungary can take this first step towards the new transition together. We can reach for additional benefits resulting from cooperation among our countries, like many
